

HOW THE MONEY IS USED



The Meso Foundation uses 86% of donations received to support its programs, 9% on fundraising, and 5% on management.



The Mesothelioma Applied Research Foundation funds critically-needed research to eradicate mesothelioma as a life-ending disease. The Foundation's Science Advisory Board (SAB) members, comprised of leading mesothelioma physicians and researchers from around the world, use their expertise to review and rank grant proposals submitted by their peers. Based on the funds generously donated to the Meso Foundation, the Board of Directors awards grants to the most promising projects.

With the conclusion of its latest funding cycle, the Mesothelioma Applied Research Foundation has reached the milestone of \$10 million in grant funding awarded to the most promising mesothelioma research projects across the globe. This Foundation is the only non-governmental institution to fund mesothelioma research through a transparent, merit-based process modeled after the National Institutes of Health.

The research funded so far spans across most areas of mesothelioma science covering topics such as validation of biomarkers, development of tools for objective measurement of mesothelioma tumors, immunotherapy, gene therapy, radiation therapy, genetics, mesothelioma prevention, and much more.

In 2017, the Foundation funded two projects, one looking into the efficacy of a cancer blocking agent specifically for mesothelioma, and the other consists of pre-clinical testing of a new target for mesothelioma treatment.

The two projects titled 'Blocking post-translational modifications of p27 for mesothelioma therapy' and 'gC1qR/HABP1/p32: A novel therapeutic target for mesothelioma (The Mary Hesdorffer Research Fund)' will be investigated by researchers at the New York University School of Medicine and Memorial Sloan Kettering Cancer Center, respectively.

The Meso Foundation held two Meet the Mesothelioma Experts live broadcasts featuring Dr. Dan Sterman of NYU and Aduro Biotech, a pharmaceutical company with a new clinical trial.

Travel Grants

In 2017, the Foundation awarded nearly \$40,000 in travel assistance to 35 grant recipients to help them access expert consultations and cutting-edge treatment.



advocacy and awareness

Congressionally Directed Medical Research Program (CDMRP), through the Department of Defense (DoD)

In 2017, the CDMRP's Peer-Reviewed Cancer Research Program, which houses merit-based funding for several cancers, including mesothelioma, was once again renewed at \$50 million. Mesothelioma researchers were able to obtain a total of \$1.57 million among four investigators. This brought the total mesothelioma research funding by the DoD to \$19.4 million. This funding was made possible by the Mesothelioma Applied Research Foundation's advocacy, which in 2008 facilitated the addition of mesothelioma as an eligible condition for funding.

Coalitions and Partnerships

Mesothelioma is this organization's sole focus. However, in the grand scheme of things, we realize that this cancer is categorized as a rare cancer. As such, we have focused much energy on fostering and expanding important coalitions and partnerships to help us achieve our common goals. Some of our collaborators in 2016 have been: the Deadliest Cancers Coalition, the National Organization for Rare Disorders, the International Association for the Study of Lung Cancer, One Voice Against Cancer, Sheet Metal Occupational Health Institute Trust, International Association of Heat and Frost Insulators and Allied Workers, International Mesothelioma Interest Group, National Health Council, Friends of Cancer Research, National Comprehensive Cancer Network, Coalition for Health Funding, American Society of Clinical Oncology, International Thoracic Oncology Nursing Forum, National Patient Advocate Foundation.

Mary Jo Lawyer Spano Mesothelioma Patient Registry Act of 2017

The Mary Jo Lawyer Spano Mesothelioma Patient Registry Act of 2015 was re-introduced by Representative Katko of New York in 2017 changing its name to the Mary Jo Lawyer Spano Mesothelioma Patient Registry Act of 2017.

The Mary Jo Lawyer-Spano Patient Registry Act of 2015 became reality as a result of a meeting two years earlier between Rep. Katko and a community member of the Mesothelioma Applied Research Foundation, Ms. Meg Meccariello. At that time, Ms. Meccariello was herself a mesothelioma patient, had a sister just diagnosed with mesothelioma, and had already lost her father and another sister, Mary Jo Lawyer Spano, to mesothelioma a few years prior. Needless to say, her story and the urgent need for life-saving treatments resonated with Congressman Katko.

Currently, there is no formal federal registry to keep track of mesothelioma patients' demographics or other important information that could help identify gaps in current mesothelioma treatment. The SEER registry isn't useful for mesothelioma patients, as they die before data is fully captured by the Centers for Disease Control and Prevention (CDC).

The profound impact of patient registries has been demonstrated in other diseases (such as gastrointestinal stromal tumors, Gaucher's disease, newborn screening for inborn errors of metabolism, interstitial pulmonary fibrosis, and muscular dystrophy) which, following their implementation, have seen an acceleration in treatment development and acceleration toward cures.
